MOTIONS/RECOMMENDATIONS FROM COMMITTEE OF THE WHOLE, DECEMBER 6, 2016

336 MAIN STREET FINAL CONSIDERATION

- The recommended changes to the 336 Main Street Development agreement include:
 - Changes to meet building code requirements
 - Reduction in parking
 - Reduction in the size of green roof and increase requirements guiding installation of green roof
 - Increase number of units, removal of common room and removal of hotel use restrictions
 - Removal of requirement for on site manager
- Council approved the draft development agreement amendments for 336 Main Street

MOTIONS/RECOMMENDATIONS FROM COMMITTEE OF THE WHOLE, JANUARY 17, 2017

EXTENSION OF MUNICIPAL SERVICES

- Council deferred the Extension of Municipal Services Motion to a Special Town Council Meeting (date to be determined)

- An invitation was extended to Wolfville's Town Council to have a member of Council sit on the Kings Point-to-Point Board
- Council appointed Councillor Mercedes Brian to sit on the Kings Point-to-Point Board as a Director

STRATEGIC PLAN

- In Wolfville it is common practice for Council to develop a four-year strategic plan following election to office. On December 13 and 14, 2016 Council and Senior Management attended a workshop to identify Council's Vision, Mission, Principles and Strategic Directions
- Council approved the one-page Wolfville Strategic Plan for 2017 to 2021

MPS PROCESS

- In 2015 Council initiated a project to review and update the Municipal Planning Strategy, Land Use Bylaw, Subdivision Bylaw and the Design Guidelines. The project was broken into two phases, with Phase 1 completed in March 2016 and Phase 2 slated for completion in the fall of 2017
- Council approved extending the contract of the term planning position until the end of Fiscal 2017-18, and funding the cost of the position to an upper limit of \$61K from reserves
